To Whom It May Concern:

The Colonnade, located at 131 Bloor Street West, provides many services to our community, including a high-rise condominium residential tower, a private school, an upscale retail/commercial mall, and two restaurants.

As the Property Manager of this Corporation since 2009 I was dealing with pinhole leaks continuously, usually more than 1 per month; with repairs often costing thousands of dollars.

I carefully reviewed the options available to stop pinhole leaks, including pipe replacement, epoxy coating and LEaC Shield. I reviewed technical and reference literature on the viability & safety of each option, and obtained pricing. Ashley Manor Housing Corporation learned about LEaC Shield several years ago through an online search. In December 2020 AMHC finalized our decision to have the LEaC Shield Pinhole Leak Prevention Equipment installed at Post Hill (132 Kingston Rd., Ajax).

Prior to installation this site was inconvenienced by frequent pinhole leaks. This was disruptive to tenants and staff and was impacting our operating budget. Since then, I have observed the successful operation of LEaC Shield's corrosion prevention system in the domestic potable water piping at Post Hill. We haven't had a single pinhole leak since LEaC Shield's installation. In the meantime, AMHC also made the decision to implement the system at a second site, Ashley Manor (40 Kitney Rd, Ajax).

To Whom it may Concern,

I am writing to recommend the implementation of LEaC Shield's pinhole leak prevention program for your building. Before implementing their service at 175 Cumberland St., I had investigated this product thoroughly over some time. Those investigations included discussion with one of the most respected mechanical engineers, Morrison Hershfield and others, calls with buildings that already use the service, Del Property Management operations experts, as well as food safety experts. All confirmed the effectiveness in its pin-hole management as well the safeness of its consumption by residents, and dispelled any concerns of negative impacts on mechanical equipment which is something Del Property Management explored at some length.

Up to the time we installed this water treatment system, we were experiencing a small but growing number of pinhole leaks over a three-year span that reached 7 pinhole leaks in that final year. This was an early warning that full pipe replacement was not that far off. By comparison, over the year and a half that it has been operating, not only did the number of leaks per year stop growing, we have yet to experience a single pinhole leak.

As a senior property manager, I have seen firsthand the significant financial impact that water damage can have on properties, particularly in multi-unit residential settings. It is costly when assuming the repairs while claiming the loss is also costly due to the increases in either insurance coverage rates or the deductibles or both which can continue for a number of years. There is also the negative impacts on living conditions borne by our residents which cannot be discounted.

My experience with both the product itself and the company operating it has been very positive to the point that I also had it installed in another building I managed at 99 Avenue Rd. I therefore have no reservations in recommending LEaC Shield for anyone interested in pushing out water pipe replacement as well as the benefits of leak prevention it provides.
